Eligibility

The LFA speech and debate league is tailored exclusively for private Christian high schools, which means only private Christian high schools or private Christian schools with a high school are eligible to become members of the league. Students who are freshmen through seniors (grades 9-12) are eligible to compete.

Membership & Duration

Both school and student LFA memberships are required for participation in the LFA or any LFA sanctioned event. School and student memberships are valid for the entire speech and debate league year, which begins August 1st and ends July 31st. Speech and debate tournaments normally occur from September through April of every year. School and student memberships are renewed annually.

Registration for membership in the LFA requires that each school and participating student submit a complete membership application and appropriate membership dues. Once a school and their students' membership registrations are complete, the school's staff and students will be eligible to participate in LFA learning opportunities, tournaments, and other LFA offered events and programs.

In addition to the membership application and membership dues, each student competing in the LFA must complete a survey, which is broken into two parts, completed at the beginning and end of the speech and debate season.

Students are ineligible to compete until both their school's and their student membership registrations and dues have been completed and paid.

Dues

School membership dues are tiered and based on the date of submission of the school's complete membership registration (membership application and membership dues). The three time segments are an early registration period, an open registration period, and a late registration period. Early registration ends on May 31, 2019. Open registration is from June 1, 2019 through August 31, 2019. Late registration begins on September 1, 2019.

School membership dues for complete registrations submitted during the early registration period are \$500 per school, \$600 per school during the open enrollment period, and \$700 per school during the late enrollment period.

For students, the open enrollment period begins on August 1, 2019 and ends on September 30, 2019. Annual student membership dues are \$15 per student for registrations completed during the open enrollment period, and \$25 per student for registrations completed after the open enrollment ending date.
